As an authorized dealer (reseller), you represent the Nowaskey Extreme Performance Brand. We are proud to have a group of dealers who offer our performance products and exceptional service to their customers.

We are confident that our line of suspensions outperforms competing brands in tunability, performance, and quality. All of our products are hand-assembled in the USA with American-made materials. Each shock is individually dyno-tuned and mated to its twin for consistent and exceptional performance.

The following guidelines are the minimum requirements to be a NEP authorized dealer.

1. You are a full-time motorsports business with a business address and phone number.
2. Provide photos of the exterior and interior of your store. We prefer storefront businesses where customers can quickly identify your type of business by the exterior, and they can walk inside to view our products.
3. Provide a copy of your business license, tax ID number, and resale/tax-exempt certificate.
4. Place an order for a minimum of (2) two sets of rear suspensions (any combination of models) within (7) seven business days of dealer approval.
5. Purchase a minimum of (6) six sets of rear suspensions per year (any combination of models). Your calendar year begins on the date of dealer approval.
6. By submitting an application, you agree to abide by the policies of the NEP Authorized Dealer Program upon approval.
